On 30-11-2013("the date of the sale") :

Balloting will be used to determine the order of priority. The persons or companies incorporated in Hong Kong (companies not incorporated in Hong Kong are not eligible) interested in purchasing any of the specified residential properties ( " the registrant(s) " ) must follow the procedures below : —

1. Each of the registrants (if the registrant is a company incorporated in Hong Kong, then any one of its directors) must submit personally

(a) the Registration of Intent duly completed and signed by the registrant;

(b) one cashier order in the sum of HK\$150,000.- ( or two cashier orders each in the sum of HK\$150,000.- if the registrant is interested in purchasing two specified residential properties) made payable to "WOO, KWAN, LEE & LO"; and

(c) a copy of the registrant ' s H.K.I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate, Certificate of Incorporation, Registers of Directors and the latest Annual Return of the registrant and the H.K.I.D. Card of the Director of the registrant (if applicable)

to The Visionary Sales Office at 1/F., Octa Tower, 8 Lam Chak Street, Kowloon Bay, Kowloon ( " The Visionary Sales Office " ) during the period from 21-11-2013 to 27-11-2013 (21-11-2013 to 26-11-2013 : from 11:00a.m. to 8:00p.m. ; 27-11-2013 : from 11:00a.m. to 3:00p.m.) in order to register for eligibility to the balloting which shall take place on 27-11-2013.

2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
3. The registrants who have submitted the registration in accordance with item 1 shall be eligible for the balloting.
4. The balloting will take place at 5:00p.m. on 27-11-2013 and the balloting will be effected via a computer network. The ballot results, including “ registration number ” , “ ballot result sequence ” and “ the check-in timeslot for registrants ” shall be posted at The Visionary Sales Office at 7:00p.m. on 27-11-2013. The opening hours of The Visionary Sales Office on 27-11-2013 to 29-11-2013 are from 11:00a.m. to 8:00p.m.
5. The registrants (if the registrant is a company incorporated in Hong Kong, then any one of its directors) shall personally attend The Visionary Sales Office on 30-11-2013 according to “ the check-in timeslot for registrants ” in the ballot results posted by the Agent appointed by the Vendor. The registrants must bring along their H.K.I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate, Certificate of Incorporation, Registers of Directors, the latest Annual Return of the registrant and H.K.I.D. Card of the Director of the registrant (if applicable) and the official receipt for the Registration of Intent. The registrants whose identities have been confirmed and verified by the Agent appointed by the Vendor shall be eligible to select the specified residential properties which are still available at the time of selection in the order of priority according to the ballot results. Registrants who arrive at The Visionary Sales Office at any time later than “ the check-in timeslot for registrants ” assigned in the ballot results on 30-11-2013 shall not be eligible to select the specified residential properties in the order of priority according to the ballot results and the registration of such registrant(s) will be deemed invalid.

午11時至下午3時)須親臨九龍九龍灣臨澤街8號傲騰廣場1樓昇薈售樓處(下稱:昇薈售樓處)遞交:

- (a) 已填妥及由登記人簽署的購樓意向登記表格,
