## On 30-11-2013("the date of the sale"):

Balloting will be used to determine the order of priority. The persons or companies incorporated in Hong Kong (companies not incorporated in Hong Kong are not eligible) interested in purchasing any of the specified residential properties ( " the registrant(s) " ) must follow the procedures below: -

- 1. Each of the registrants (if the registrant is a company incorporated in Hong Kong, then <u>any one of its directors</u>) must submit <u>personally</u>
  - (a) the Registration of Intent duly completed and signed by the registrant;
  - (b) one cashier order in the sum of HK\$150,000.- ( or two cashier orders each in the sum of HK\$150,000.- if the registrant is interested in purchasing two specified residential properties) made payable to "WOO, KWAN, LEE & LO"; and
  - (c) a copy of the registrant 's H.K.I.D. - 2. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).
